Shoring - Prequalification

Site: York Quay Phase 2 is located at 225 Queens Quay. The project is directly south of Queens Quay, between the Queens Quay Terminal and the Enwave Theatre / Harbourfront Centre.

Background Information: The York Quay Phase II Project will consist of the replacement of the existing 212-spot surface parking lot (a 1.4 hectare or 3.5 acre site) with a three-storey 12,000 square meter of gross floor area (GFA), underground parking garage for approximately 300 cars and a new artistic water facing landscape park/square (Canada Square) and a new entrance and landscape square into Harbourfront Centre (Urban Square).

Scope: The York Quay Revitalization Project - Phase II Secant Wall is intended to be designed as a composite structural wall forming part of the permanent structure basement walls with

approximately 350 - 1 metre diameter caissons, which includes primary and fillers at a frequency of 1:1 with a 200 mm full depth interlock. Approximate depth of caissons is to be 18m deep and the wall is to include two levels of tie-back anchors. Schedule: Approximate schedule for this portion of work is;
