Dear Mr. Dawson:

Thank you for submitting the Toronto Transit Commission's (TTC's) Terms of References (ToRs) for the Toronto Waterfront Transit Projects for East Bayfront, West Don Lands and Port Lands on July 14, 2006 and the revised ToRs on August 31, 2006. The ministry has completed its review and I wish to inform you that I have approved TTC's ToRs for the preparation of environmental assessments (EAs) for its transit projects, with amendments.

Prior to making my decision, I directed the Interim EA Facilitator to review the ToRs. The use of a Facilitator was initiated at the recommendation of the EA Reform Panel that was convened by this ministry to evaluate the EA process in Ontario and propose changes that would improve the process for waste management facilities, transit and transportation projects, and clean energy facilities. The objective of the Facilitator in reviewing the three ToRs prepared by TTC was to make recommendations for changes to the provisions and requirements of the ToRs that would result in an overall more effective and efficient EA process. I would like to take this opportunity to thank TTC for working cooperatively with the Facilitator. The ToRs have been amended by my approval to reflect the strengthened provisions and requirements that were recommended by the Facilitator and agreed to by TTC.

As required by subsection 6.1(1) of the Environmental Assessment Act, TTC's EAs must now be prepared in accordance with the approved ToRs. While this approval provides additional certainty to TTC's EA decision-making process, it does not secure approval of an undertaking. TTC is responsible for fulfilling the commitments outlined in the ToRs and providing the appropriate level of quality in the EAs.
